#### **Concentration Approval**

Maximum of 2 credits per semester may be counted toward the IR concentration. If abroad for one year, 4 credits may, with concentration advisor approval, be applied toward IR (2/semester). In IR, study abroad courses may fulfill the regional requirement or, if directly related to the concerns of the chosen track, and approved by the concentration advisor, one track course. GLISPs require pre-and post-approval just like any study abroad course. Language study done abroad may also be applied to the language requirement, typically fulfilling one semester of the language sequence. Credit for language study while abroad is determined by the appropriate language department at Brown.
