About the Master of Public Affairs Program

The Master of Public Affairs (MPA) at Brown University's Watson Institute for International and Public Affairs is an intensive one-year (June to May) program. Students develop the analytic, communication, and strategic leadership skills they need to tackle societal challenges.

MPA students can expect a rigorous and well-rounded curriculum, but also the flexibility to ensure they graduate with the knowledge and experience needed to succeed in their careers. Students can choose from faculty-driven policy specializations, or they can create their own, benefiting from a diverse faculty and access to a multitude of graduate offerings.

Unique to the MPA progam is an emphasis on global policy — a ten-day trip to an international site is a required component of the program. The degree also requires a ten-week Policy-in-Action Consultancy in the spring. This consultancy, coupled with elective coursework in a policy specialization, provides all our students with the opportunity to develop the ideas, knowledge, and skills needed to make a difference.

Policy Specializations

The MPA program's specializations enable students to pursue deeper knowledge and gain proficiency in the methods and substance of particular policy areas.

Comparative and Global Policy

This specialization focuses on the policy settings where international rules and cross-national differences take a central place in decision-making. Courses in this specialization illuminate the conditions that shape the choice of policy goals and the design of specific instruments in different

countries. Since the interplay of political purposes and economic incentives looms large in all policy decisions, the specialization emphasizes a political economy approach, broadly understood. The specialization allows students to focus on the policy challenges that face developing countries, middlerange countries, advanced industrial democracies, or a combination. Students are also able to emphasize international perspectives on a range of domains, including industrial development and economic growth, international security, and global financial stability.

Data-Driven Policy

This specialization prepares MPA students to undertake data analytic work in government, nonprofit, and for-profit organizations. Students are introduced to a variety of programming languages used to manipulate and analyze data including Stata, SQL, and Python, and gain the tools to turn large data sets and behavioral science into improved policy. Students also acquire hands-on experience with data cleaning, analysis, visualization, and designing and implementing policy evaluations. For the Policy-in-Action Consultancy, students work in a policy lab at Brown or elsewhere to integrate data-driven research with experiential learning. Students also write a term paper that demonstrates their ability to use programming, data visualization, and empirical tools to provide systematic evidence of a public policy problem or rigorously evaluate the effectiveness of various policy solutions.

Policy Analysis

This specialization deepens students' skills in the application of economic analysis to questions of policy design, efficiency, and distribution. Students gain familiarity with cost-benefit analysis, cost-effectiveness analysis, and other applications of quantitative modeling and political economy models and become more effective critical consumers of social science research on the public and private impacts of policy decisions. Courses emphasize

valuing benefits and costs in primary and secondary markets, dealing with uncertainty, sensitivity analysis and the value of information, and understanding the dynamic between politics and markets.

Social Change and Advocacy Policy

This specialization prioritizes social justice, diversity, and ethics by using the distance between the way things are, and the way things ought to be, to shape learning and to analyze and generate policy and public interventions. Courses facilitate rigorous, critical examination and assessment of public action in analytical as well as prescriptive ways, encouraging students to think about how norms for public action emerge, and their own role, as dedicated public actors, in that process.

The specialization focuses on how power works, how change happens through policy and public mobilizations and partnerships, and how policy makers and analysts can develop not only maximally effective but more ethical and just work. Throughout the consultancy, students participate in individual faculty advising as well as professional and project management sessions. Each project culminates in a final report that can be used as a professional writing sample during the career search process. The consultancy is designed to:

- Provide a career springboard through a rigorous, practical immersion with a client.
- Deliver value for both community partners and students.
- Focus on experiential learning and creative problem solving.
- Address complex contemporary problems, explore policy and practice-based solutions, and identify strategies and recommend future approaches.
- Develop policy and practice-related solutions to address policy issues and/or enhance an organization's capacity.
- Accelerate proficiency in project management, stakeholder identification and analysis, systems and strategic thinking, and effective presentation of data.

Consultancy Requirements

The consultancy is part of coursework that starts in the summer and continues through completion of final deliverables in the spring. Students receive academic credit upon successful completion of the consultancy.

- **Summer sessions:** Career planning sessions and site preferences discussion.
- Fall semester: Attendance at several seminars on consultancy best practices and the selection and preparation process.

Design Your Own

Students may work with their faculty advisor to design their own specialization. Students must gain approval to take electives outside of the recommended courses from the Director of Graduate Studies.

Policy-in-Action Consultancy

The ten-week Policy-in-Action Consultancy is a hands-on, one-credit learning program designed to help students shape and implement an innovative project with a client in the nonprofit, public, or private sector. Students apply their skills to address real problems while doing work consistent with their professional goals.

• **Spring semester** (simultaneous with consultancy): Individual project management and analytical support meetings and professional development coaching sessions. Customized problem-solving sessions under the mentorship of Brown faculty and staff members.

Final deliverables at the end of the spring semester include:

- Comprehensive consultancy project research/analysis report including recommendations for the organization.
- Post-consultancy presentation.

Global Policy Experience

During the ten-day Global Policy Experience (GPE), students analyze and explore public policy at an international location. Summer 2018 sites will be announced soon. A core course during the fall semester, The Politics of Policymaking in Comparative Perspective, enables students to place lessons from the GPE in an analytic framework. Features of the GPE include:

- Meeting with high-level public officials to explore the political and economic dynamics affecting the world's nations.
- Exploring dynamic policy environments: past sites include Cambodia, Korea, Sweden, Brazil, Germany, and India.
- Learning how global forces are transforming policy agendas and how different nations are tackling common challenges, from poverty to pollution.

Career Services

The MPA program provides a dedicated public affairs career specialist to coach students throughout this professional program. The program offers an array of services, workshops and resources exclusively for MPA students. The careers director also conducts a career assessment to create a tailored career development plan with each student. Specific actions include:

- Coaching students individually to explore options within the public policy arena.
- Helping students identify skills and strengths in order to develop a career vision and career search plan, along with the tools to achieve that plan.
- Building promotional tools including crafting an elevator pitch, and writing targeted resumes and cover letters.
- Developing public sector and policy oriented interview skills and techniques for clinching the offer.
- Developing a networking and resource list tailored to each student.

Placement Support and Employer Relations

The MPA program offers assistance in researching career options and a robust placement support program. Additional resources include:

- Database of prospective internships, consultancies, fellowships, and employment in the nonprofit, private, and public sectors.
- Brown's ongoing development of relationships with prospective employers.

- Curated list of Brown alumni active in the policy field worldwide.
- On-campus events for prospective employers, internship managers, and alumni.
- Opportunity to attend the annual All Ivy Environmental and Sustainable Development Career Fair.
- Opportunity to attend two days of Brown- and MPA programsponsored career networking events in Washington DC. Includes an alumni panel, alumni networking, employer visits, and attendance at the Nonprofit and Government Career Expo.
- Individual financial support consideration for career-specific symposia and events.

Watson Institute

The Watson Institute for International and Public Affairs provides students with close access to renowned faculty, researchers, visiting scholars, and speakers. The Institute seeks to promote a just and peaceful world through research, teaching, and public engagement. The Institute's work focuses on development, security, and governance. The Institute is a community of scholars and practitioners whose work aims to help us understand and address the world's great challenges, such as globalization, economic uncertainty, security threats, environmental degradation, and poverty. From the Americas to China, from the Middle East to South Asia, the strongest theoretical models emerge through observations and analysis in the field.

111 Thayer Street and 59 Charlesfield Street

Master of Public Affairs students have 24/7 access to both the main building at 111 Thayer Street and 59 Charlesfield Street (known as 59C). The third floor of 59C serves as a dedicated study lounge for MPA students, with several desktop computers, printer, copy machine, and scanner available for use. MPA staff reside in both 111 Thayer and 59C.

Under Construction

A fully renovated building at 63–65 Charlesfield Street and newly constructed building at 280 Brook Street are slated for occupation by the Watson Institute beginning in January 2019. Joined by a bridge, the two buildings will expand the Institute's footprint by 31,000 square feet, adding a large commons for socializing and events, classrooms, meeting and study space, offices, and a cafe.

Living in Providence

Providence, Rhode Island's captial city, has been ranked one of the most livable cities in the U.S. With its many universities and vibrant arts scene, the city is one of southern New England's premier cultural destinations.

Brown University is nestled in the midst of dynamic and historic neighborhoods on the city's **East Side**. **Thayer Street** is a student hub with shops and many eateries. **College Hill**, adjacent to campus, is known for its historic homes and attractive residential streets. **Blackstone Boulevard**, a mile east of Brown's campus, has a 1.7 mile walking/running path. South of campus is **Fox Point**, which has a strong Portuguese identity. **Wickenden Street**, part of Fox Point, offers eclectic shops and popular eateries. More shopping, restaurants, and housing can be found north of campus around **Hope Street**, and to the east in the area known as **Wayland Square**. Providence is known for great food, including a number of nationally recognized restaurants. **Federal Hill**, originally an Italian outpost, has more than a dozen restaurants on Atwells Avenue. Both **DownCity** and the **West Side** of Providence have more of a city vibe.

Many options exist for living arrangements as a graduate student. Brown's campus is bordered on three sides by residential areas with an abundance of apartments and multi-bedroom houses. Most graduate students choose to live in the neighborhoods surrounding Brown. Here are ways to investigate your options:

- Graduate Student Community: Sign up for the graduate student bulletin board (GSBB), which is the main channel for current graduate students to post about roommate opportunities, rentals they are moving out of, and a range of other want-to-buy/sell opportunities.
- **Brown University Auxiliary Housing:** This office operates limited Brown-owned off-campus housing for incoming graduate students, which can be a convenient option for students arriving from a distance. Most graduate students prefer to live in off-campus accommodation. This office is not just about Brown housing: staff have a wealth of experience of local neighborhoods, and knowledge of established rental opportunities.
- The Graduate Student Wiki Housing Page (requires Brown university login): The Grad Student Wiki is populated and updated by grad students for grad students. Here you can check out informal and unofficial advice on housing issues, neighborhoods, landlords, and the graduate experience. The Wiki offers advice and collected knowledge on many other aspects concerning life at Brown and in Providence.

Founded on religious freedom, Rhode Island boasts a number of the country's "first" churches, including First Baptist Church, located near Brown. Scores of museums are located throughout the state. An appreciation of the performing arts is evident in the state's many fine professional and community theater, dance, and musical organizations.
