Research Program and Extramural Funding

MY PROGRAM of RESEARCH involves conducting longitudinal epidemiological investigations, mixed-methods (qualitative/quantitative) research, and developing and testing both behavioral and biomedical intervention trials in three primary areas:

1) HIV primary and secondary prevention (both epidemiology of, and developing and testing behavioral interventions), including PrEP (once-daily oral pill—emtricitabine/tenofovir—as pre-exposure prophylaxis for the prevention of HIV in uninfected individuals), nPEP (non-occupational post-exposure prophylaxis for sexual or injection drug exposure), and antiretroviral therapy (ART) demonstration and medication adherence intervention trials, as well as HIV prevention in the context of co-morbid mental health conditions.

- 2) <u>Substance abuse prevention and treatment</u> development studies for crystal methamphetamine and other stimulant (cocaine, crack) dependence in the context of concurrent HIV sexual risk behavior and/or suboptimal HIV related primary care.
- 3) <u>Global public health research</u> that universally takes place in settings for which very little, if any, work has been done with respect to HIV prevention, treatment for substance dependence, and addressing

intertwined psychosocial syndemic conditions (e.g., depression, victimization, etc.) that potentiates HIV risk behaviors and infection.

My federally funded studies involve a variety of populations, including sexual and gender minorities (LGBT individuals) and other key populations and marginalized groups, including adolescents, injection drug users, MSM, heterosexual men and women, individuals who engage in transactional sex, transgender women, substance users, and individuals in resource limited settings globally.

In addition to my domestic research program, I have ongoing global public health research studies across multiple continents focused on HIV primary and secondary prevention. **These countries include:**

My research in the area of HIV prevention is internationally known through my success in NIH funding for my R-level grants, as well as my participation in the National Institute of Allergy and Infectious Disease (NIAID) funded biomedical clinical trials networks (mentioned above under examples of recognition): the HIV Prevention Trials Network (HPTN), HIV Vaccine Trials Network (HVTN), and Center for AIDS Research Network of Integrated Clinical Systems (CNICS).

Epidemiology of HIV antiretroviral exposure from whoonga use in South Africa

Some people are exposed to HIV antiretroviral medication through recreational use. This emerging phenomenon poses a significant obstacle to efforts to address the global HIV pandemic. Any antiretroviral exposure from recreational use may increase rates of antiretroviral-resistant HIV strains. This and any diversion of antiretroviral medication for recreational use will increase the cost of delivering this life-saving care. The proposed research will document antiretroviral exposure from the use of whoonga, a drug cocktail in South Africa that may contain antiretroviral medication and illicit drugs. It will also inform future research to link recreational antiretroviral use to antiretroviral resistance among HIV-infected individuals who have yet to initiate HIV treatment, as well as promote the design of culturally appropriate interventions.

Fostering resilience to psychosocial and HIV risk in Indian MSM

This study is testing the efficacy of the self-acceptance-based intervention in comparison to HIV / VCT on co-primary outcomes: STI incidence and reduced episodes of unprotected anal sex among HIV-infected and uninfected MSM in Chennai and Mumbai India. The incremental cost-effectiveness of the intervention and HIV/STI VCT relative to HIV/STI VCT alone is being assessed, considering individual and public health benefits as well as downstream cost-savings due to HIV infections averted.

TransPrEP: Social network-based PrEP adherence for transgender women in Peru

This research is to develop a social network-based intervention to promote PrEP adherence among PrEP naïve transgender women at risk for HIV infection in Lima, Peru. Once the intervention is developed through multiple forms of qualitative methods, an RCT pilot will be conducted randomizing by social network-based clusters of transgender women. All participants will be provided with daily Truvada for the study period. The intervention includes a mix of individual counseling, group (peer) based workshops, and social network interactions.

HIV prevention intervention for young transgender women

The purpose of this study is to test the efficacy of a uniquely targeted HIV risk reduction intervention for young transgender women (YTW), ages 16 to 24, at risk for HIV acquisition or transmission. We will enroll 375 at risk YTW, ages 16-24; two-fifths of the sample (N=150) randomized to the intervention will participate in the 6-session group-based and manualized Life Skills intervention; two-fifths (N=150) will be randomized to the standard-of-care condition; and one- fifth will be randomized to the time-matched attention control condition (N=75) and receive standard health promotion information in a group-based multi-session format.

Optimizing PrEP uptake & adherence among stimulant using MSM

This study is to further develop and pilot test— in a two-arm randomized controlled trial (RCT)—a PrEP adherence intervention for stimulant-abusing MSM who are at risk for HIV infection against a standard of care condition. Exploratory research to reduce health inequalities among HIV positive adolescents in Brazil

HIV prevention and trauma treatment for MSM with childhood sexual abuse histories

Testing brief messages for Black & Latino MSM: emerging HIV prevention options

This 3-year CDC study includes Black and Latino MSM in three major US cities, including Chicago, Fort Lauderdale, and Kansas City, with variation in HIV serostatus and sexual risk behavior. Technology for HIV prevention among vulnerable men in India

Male sex workers (MSWs) are at particularly elevated risk for HIV infection and represent an important bridge population potentiating the HIV/AIDS epidemic in India. The first six months will be an intervention development and refinement phase. We will first conduct qualitative interviews (N = ~20 at both the Chennai and Mumbai study sites) and focus groups to inform the content of the intervention. Behavioral activation and HIV risk reduction for MSM with crystal meth abuse

Problematic crystal methamphetamine ("meth") use is a prevalent and treatment refractory problem in MSM, and highly associated with HIV sexual risk behavior. MSM who are HIV-uninfected and meet DSM-IV criteria for a diagnosis of meth (amphetamine) abuse/dependence will be randomized. Understanding PrEP implementation among club drug using MSM

The use of the antiretrovirals tenofovir emtricitabine as pre-exposure prophylaxis (PrEP) is a novel biomedical HIV prevention strategy to help decrease HIV spread. Narrative Report

Overview. I am a Tenured, Full Professor of Epidemiology, Behavioral & Social Health Sciences, and Psychiatry & Human Behavior (School of Public Health and Alpert Medical School), as well as Director of the Institute for Community Health Promotion (ICHP) at Brown University. The Institute is comprised of Faculty, Post-Doctoral Fellows, Graduate & Undergraduate Students, Core Research Staff (e.g., RAs, Project Managers), and 3 fulltime Administrative Personnel (i.e., grants management, finance, and Institute operations). We have collective expertise in intervention development and testing, clinical trials, advanced epi methods and biostatistics, qualitative methods and analysis, and program evaluation.

Past and Current Extramural Funding and Scientific Review. To date, I have been the principal investigator of 24 extramural funded research grants, including ten NIH R-level grants (3 R01s, 4 R21s, 2 R34s, and 1 R03), 1 NIH competitive supplement, 2 large-scale CDC U01 research grants, 2 Harvard Center for AIDS Research grants, 1 Harvard Catalyst grant, 1 Ragon Institute grant, 1 Brown Seed Grant, 1 Watson Institute Pilot Grant and 1 Lenovo Hope Fund Scholars Grant. My extramural research funding as PI has totaled nearly 20 million dollars. In total, I have been a Co-I or primary-/Co-mentor on over 37 federally-and foundation-funded research grants.

Notably, I am currently a standing member of the NIH Behavioral and Social Consequences of HIV/AIDS (BSCH) study section that reviews grants related to behavioral and social science aspects of HIV prevention research (8-year term, until 2019).

Global Health Research. I currently have international research studies across multiple continents focused on HIV prevention among various populations at risk of acquiring or transmitting HIV. Current countries where I am engaged in health research include: South Africa (Durban/Umlazi), Zambia (Lusaka), Thailand (Chiang Mai and Bangkok), Vietnam (Ho Chi Minh City), India (Mumbai, Chennai and Pune), Brazil (Rio de Janeiro), Ecuador (Quito), Peru (Lima), and collaborating on research projects with investigators at U Penn in Ukraine (Kiev) and Russia (St. Petersburg).

Scientific journal and Other Scholarly Publications. I have over 220 peer-reviewed, original research publications, book chapters, and reviews/commentaries. Many of my publications are in high-impact journals, including JAMA, AJPH, Drug and Alcohol Dependence, Archives of Sexual Behavior, Journal of Urban Health, Lancet, AIDS and Behavior, JAIDS, AIDS, PLOS ONE, etc. Over 1/3 of my research publications are as first author, 1/3 are as senior author, and >90 publications that resulted from my direct mentorship of individuals within the Harvard or Brown systems for which these mentees are first author on these publications.

Teaching. I am actively involved with teaching ongoing courses at Brown University, including "PHP 2360: Designing and Evaluating Public Health Interventions," an advanced graduate-level course that provides practical training in intervention development and testing (from formative, to open pilot, to pilot RCT, and ultimately, to efficacy and effectiveness trials), as well as, "PHP 2090: Scientific Writing, Research Presentation, and Proposal Development," an advanced graduate- and post-graduate-level course to enhance scientific writing skills, including the preparation of scientific journal manuscripts and federal grants (i.e., NIH and CDC grants).

Over the past 8 years, I have been teaching seminars in the Behavioral Medicine and Adult Cognitive Behavioral Therapy (CBT) tracks in the Department of Psychiatry at HMS/MGH. I was also actively involved with teaching at HSPH in the Department of Epidemiology for the past 8 years (2007-2015). My primary course, EPI 220, was an applied, mid-level course in the psychiatric epidemiology track that focuses on interview schedules designed to diagnose psychiatric disorders in clinical settings, household surveys, and behavioral research. The course provides practical experience in differential diagnosis, in the administration of different kinds of interview schedules, and in analysis of responses.
